Expenditures and Receipts

Chairman Erwin read the 2021 expenditures and receipts in full.

Motion carried, with all voting "Aye" on a voice vote.

Project Graduation

Constituent Joanne W. suggested increasing the donation to Project Graduation from \$100 to \$200.

Economic Development

Chairman Erwin stated that Wendy Gehloff would be leaving the as head of the Florence County Economic Development.

He proposed donating \$300 to the Economic Development for 2022.

Town Dump Disposal Prices

Madeleine Lane

Constituent Pat W. inquired what the status was of Madeleine Lane. Chairman Erwin stated that he checked with Kevin from the Florence Utilities, and they are putting the power underground, but he was not in favor of moving the utility pole.

Chairman Erwin stated that if Joe Witynski pursues the improvements to give the road to us there will be a special assessment to the people on the Lane.

Constituent Pat W. stated they need to be careful where they install the culvert, or it could cause flooding and draining issues.

Constituent Pat W. stated that Joe Testolin will need to fix an oil leak on the town truck.

Constituent Pat W. stated that a proposal for removing the mold and old insulation in the town garage. The hired contractor must also be certified to remove the mold.

Chairman Erwin stated he would check with CLS Construction for this project.

Town Dump Fencing

Constituent Pat W. stated that he will take down and salvage what he can of the old fencing and poles.

Chairman Erwin thanked the Town Board for all their efforts. Constituent Joanne W. thanked Fred for his service too.
