#### A&K Tree Service

Chairman Erwin introduced Tony Kligas from A&K Tree Services. Tony stated that he has had his own business for 3 years, has his own equipment and is bonded and insured. He stated that he has the capabilities to do all types of tree service work and that he is a certified climber.

Tony stated that this is his slow period so he could start trimming immediately. The town will approve up to \$10,000 to start trimming.

Chairman Erwin will meet with Tony and Pat tomorrow at the town garage to show Tony the trees that require trimming. He will call Tony with a time.

Motion to hire A&K Tree Service for the 2023-2024 calendar year made by Supervisor Drewa. Motion seconded by Supervisor Saak.

Motion carried, with all voting "Aye" on a voice vote.

Supervisor Saak requested a daily log of the work done too.

#### Madeleine Boulevard

Chairman Erwin stated that Joe Podnar was unable to make the meeting tonight. He stated that he had found the signatures and a copy of the survey and legal description of the road.

Supervisor Drewa asked if constituent Whaley was paid up on her taxes and if there was an address for her. He stated that each resident on the road would have to pay for the road repairs.

Supervisor Drewa stated that Universal Plumbing and Heating will be coming to tune up the town furnaces. He will let Pat know when.

Supervisor Saak asked if Nsight had completed the internet installation at the town hall yet. Chairman Erwin stated that he will check with them.

Supervisor Drewa stated that Pat had asked if he could have the plow sandblasted and painted. It was decided this was okay.
